2. Employee search (Employee search, Absence search, Accident search) - fixed bug in search logic which caused a problem with the search results anytime the multiple select lists were

### **Employee Manager -**

1. Fixed handling of attachments on Accidents
2. Fixed load of contributing factors on Accidents
3. Notes- changed load so they will display in desc order by note date
4. Notes- when a new note is added the user's login name will be saved to "Entered by" instead of the generic "User"

- b. New field in EMPTRAIN\_TRANS
- c. EMPTRAIN\_TRANS has a new index, EMPNUM\_GROUPID (making each EMPNUM and GROUPID combo unique... Employee can not be in the same training class more than once)
- d. DISTRICT has a new field, called DistLogo2 set to data type Ole Object (to accomodate DistLogo in .NET)

## ***Updated 11/09/05-11/18/05 in Version 1.1.6.1***

### **Changes in Employee Manager –**

1. To allow clients to run over Terminal Server or other remote application server model, changed code to look at a setting "AllowMultipleInstances" in the file, "EmployeeManager.exe.config", stored in the application directory. If setting is set to 'true' then application is allowed to be opened more than once, otherwise application will give a message to the user that it is all ready running and shut down.
2. Put code into licenses.licx that is used by Active Reports and should eliminate trial banner from being printed on reports.
